## ASIA COOPERATION DIALOGUE (ACD) ENERGY ACTION PLAN

#### I. Introduction

Energy is one among the six pillars of cooperation in the ACD, several meetings have been held within the ACD framework to advance energy cooperation among its member states. The 3<sup>rd</sup> ACD Ministerial Meeting in Qing Dao, China, in June 2004, agreed on promoting energy cooperation as listed in the Qing Dao Initiative. This Initiative listed priority fields of cooperation, which include: exchanging of information and views; encouraging cooperation in energy technologies, exploration, exploitation, infrastructure; promoting conducive environment for investment; strengthening cooperation in energy efficiency and conservation and renewable energy; promoting human resource development and capacity building and food-water-energy nexus.

The current Energy Action Plan was reviewed by the ACD Energy Prime and Co-Prime Movers on the 20<sup>th</sup> of December 2016, during their meeting in Abu Dhabi, UAE, and updated thereafter on the Energy Working Group that held its meeting on the 15<sup>th</sup> of January 2017, for further consideration. Finally, the plan will be presented to the 15<sup>th</sup> ACD Ministerial Meeting happening on the 17<sup>th</sup> January 2017, in Abu Dhabi, UAE.

At the 1<sup>st</sup> ACD Energy Forum held in Bali in September 2005, the need to formulate an ACD Energy Action Plan was underscored to serve as a blue print for a collaborative approach in implementing energy programs and projects for the realization of enhanced regional security and sustainability of energy resources and technologies. The Doha Declaration of the ACD Ministerial Meeting in May 2006 welcomed the Initiative and reflected the sense of ACD members to accord "priority in energy security, research and assessment in energy, energy infrastructure development and encouraging member countries to explore the possibility of re-investing revenues that accrue from the energy trade in the ACD Countries". On the other hand, the Manama Declaration, the outcome document of the Conference on Energy and Climate Change held in November 2008, emphasized the need to strengthen on efforts made by member states in promoting and strengthening of relations in Asia, in all primary areas of cooperation, and in particular in energy and climate change.

The growing awareness on the importance of investments in and utilization of all energy sources including new and renewable energy sources are further reasons for an effective cooperation in the energy field for the ACD. Therefore, the ACD Energy Action Plan is necessary to be an important document on energy cooperation among ACD member states.

Further to these declarations and recommendations from previous ACD ministerial meetings and other ACD energy related meetings is the outcome of the first ACD Summit held in Kuwait in October 2012. Acknowledging that energy security is a "regional and global challenge facing ACD member countries", and that "sustainable energy is a key factor in achieving prosperity and economic growth in Asia", the ACD member states agree to move forward its energy cooperation with the "review, finalization, and adoption of the ACD Energy Action Plan."

#### II. Plan of Action

## A. Areas of Cooperation

The Plan of Action should enable the ACD member states to build a cohesive cooperation forum that will ensure the institutionalization and materialization of energy cooperation in Asia. It should serve as framework in ensuring energy security and promoting energy accessibility and sustainability. It is intended to be implemented for a period of five (5) years reckoned from its adoption during the 12<sup>th</sup> ACD Ministerial Meeting in Manama, Bahrain in November 2013. It will essentially consist of four thematic core areas of cooperation in order to promote energy security, as follows:

- 1. Promotion, development and utilization of all indigenous energy resources and renewable energy technologies;
- 2. Enhancement of energy efficiency and conservation initiatives programs;
- 3. Encouragement of bilateral or multilateral cooperation and coordination towards the creation of electricity markets among groups of ACD countries;
- 4. Promotion of cooperation between Member States on climate change.

## **B.** Implementation of Areas of Cooperation

In implementing four thematic core areas of cooperation in the region, it is proposed that ACD member states need to consider actions as follows:

- 1. Promoting information exchange and sharing of best practices on energy policies, plans and programs among the ACD Member States.
  - a. Encouraging states to exchange and share views on their domestic energy situations and the international energy market with a view to facilitating mutual benefits for both consumers and producers in Asia in various energy sources. Facilitating exchange of information and building capabilities in innovative development sphere and transfer of energy related technologies.
  - b. Sharing information on clean combustion, energy efficiency and conservation techniques and technologies.
- 2. Promoting investment in energy in ACD Member States by enacting and/or launching the necessary legislation and/or policies based on each domestic circumstances to incentivizes investment.
- 3. Enhancing capacity building of human resources on all aspects of energy exploration, development and utilization.

#### III. Source of Funding

Unless otherwise agreed, cost of activities under this action plan should be based on the contributions of ACD interested states on a voluntary basis and the assistance by third parties, including international organizations.

#### IV. Progress and Involvement

The ACD Members States may suggest and promote any other activities not listed in Annex I, making the Plan of Action a living document

ACD will work closely with other regional and international organizations in the energy sphere to maximize positive outcome and promote complementarity of work.

Member states will inform the Secretariat with the activities and the feedback on these activities.

The action Plan will be updated in the next meeting, if needed, in August 2017 planned to be held in Philippines, and if there is any change required, it will be submitted to the 16<sup>th</sup> Ministerial Meeting that will be held in Islamic Republic of Iran.
